REASON FOR TODAY'S CALL:

Hey there! Simple request here. I own a condo West of Denman and the drains are all starting to get pretty slow. There's three: kitchen sink, bathroom tub, and bathroom sink. The first two are the usual, the bathroom sink has a bit of a longer pipe after the trap, into the wall (see photo attached). I'm guessing they just need to be snaked and potentially have the traps removed to be cleaned out (particularly the bathroom one given its drain plug etc, but you'd know best. Note I put down email as preferred way to contact, but either way is fine by me. Thanks! Michael *free parking around back.

DESCRIPTION OF WORK PERFORMED:

I used the PowerSpin drain snake to clean the kitchen sink and lavatory drains. Tested by filling and draining the sinks multiple times. I noticed a small leak coming from a loose connection on the lavatory drain. I tightened this connected and the leaking subsided. I was unable to guide the PowerSpin drain snake through the tub drain but was able to clear hair and gunk out of the top of the drain. Tested by filling the tub 6" and draining multiple times. It is now flowing much better.
