## DESCRIPTION OF WORK PERFORMED:

FEB4: I made a trip to the unit and found water to be leaking out of the handle as well as through the faucet itself. The nut that secures the cartridge in place worked itself loose. I tightened this nut which seemed to have stopped the leak from the handle but this nut should not have worked itself loose like this. I will contact Delta and ask for a replacement under warranty. MAR1: Delta sent me a replacement faucet free of charge under warranty. Before I could install the new faucet I first had to repair the shut off valves under the sink(connected to the faucet) as they were not fully shutting the water off. I repaired these valves by replacing the washers, stems, packing, packing nuts, and handles. I then installed the new faucet and tested.
