REASON FOR TODAY'S CALL:
Low water pressure in kitchen faucet.

DESCRIPTION OF WORK PERFORMED:
I found debris in the screen between the kitchen faucet and the spray hose. I removed this screen and cleaned it. I then reattached the spray hose, removed the faucet spray head, and flushed debris through the faucet for 5 minutes before reinstalling the screen and spray head. Pressure is back to normal but this debris is coming from the building's main water risers and could clog up the faucet again in the future. I imagine that every time there is a water shut down of these main risers the chances of this debris building up will be greater.
