-replaced laundry hoses with braided stainless type. -tightened kitchen faucet. -replaced garburator -tightened shower head -instructed home owner on shower operation -tested all fixtures for operation. All seem to be in good working order. -inspected kitchen sink for leaks, could not find any leaks present. Filled both sinks and drained. All connections are tight, no leaks present at supply lines or drainage.
