Toilet was clogged. Used 6' toilet auger and unclogged it right away. Ran auger through a few times with no problem. Flushed rolled up balls of toilet paper and toilet was slow to flush. Checked other toilet and it flushed the same way. The reason the toilet clogs all the time could be because of the low flow toilets.

**TECHNICIAN RECOMMENDATIONS:**

if this toilet continues to be a problem we may want to look at removing the toilet, putting a large drain snake down the line, and making sure there is no blockages further down the line.
