REASON FOR TODAY'S CALL:

-leak under kitchen sink. Believed to be coming from garburator mounting bracket

DESCRIPTION OF WORK PERFORMED:

-found a leak coming from the garburator mounting collar. The collar was about half way between all the way tight and all the way loose. I tightened this collar and tested by filling the sink and draining 3 times. -there is a cover plate missing from the bottom of the garburator allowing the wires to hang down. I taped these wires and placed them up inside the bottom of the garburator and out of the way. -tenant asked about the location of the main water shut off valves within the unit, I showed him where they were and how to use them.

TECHNICIAN RECOMMENDATIONS:

-the switch for the garburator works but only if you apply pressure to the switch in open position. This would need to be addressed by an electrician.
