 -tub and lav drainage blocked.

DESCRIPTION OF WORK PERFORMED:

DEC9--Used PowerSpin drain snake to clear tub drain. Started in the overflow of the tub. That didn't work so I went down the lav drain. Cleared the blockage, but got the snake stuck in the drain. Cut open the wall and removed a section of pipe. Tried to remove cable from there, but was unsuccessful. Replaced section of pipe with abs. Need to go down stairs and open up more pipe to remove cable. Dec10- cut out section of drainage in ceiling of 301. Found cable to be wrapped up on what appears to be tampons, hair and floss. Cable had wrapped its self around this and kinked in the pipe. Removed cable and repaired piping with abs. Tested tub and sink upstairs to ensure no leaks. (I have also saved the section of cable with everything attached to it. Took some photos and sent them to darren)
