REASON FOR TODAY'S CALL:

1. Shower diverter in main bathroom does not stay up when pulled up; 2. sink in bathroom is not draining; 3. chain in toilet in main bathroom is broken; 4. lower bathtub faucet in second bathroom is leaking; and 5. garburator is not working.

DESCRIPTION OF WORK PERFORMED:

GARBURATOR: I unjammed the garburator and during testing found that cracks in the housing were allowing water to seep out. I replaced the garburator and tested by filling and draining the sink while running the garburator. TUB/SHOWER DIVERTER(master): I took pictures of the tub spout and will quote repair once I have pricing and availability of parts. LAVATORY DRAIN(master): I used the PowerSpin drain snake to clear the sink drainage. TOILET FLAPPER: I replaced the flapper in the master bathroom. TUB FAUCET(guest): Replaced mixing & pressure balance cartridges.
