 Master bathroom tub/shower diverter not working(Danze)

DESCRIPTION OF WORK PERFORMED:
 Feb6---I removed the diverter assembly, replaced the seat and spring, and re-installed. This resolved the issue of diverting water from tub to shower but I noticed there is a small amount of water dripping out of the stem of the diverter assembly. I have emailed Danze's customer support and will follow up with the tenants when I hear back about the availability of parts. Feb25---I received the replacement diverter spool and installed.
