Toilets: All seem to be plugging at the same time, every time they flush the master bathroom keeps plugging up

DESCRIPTION OF WORK PERFORMED:

-The master bathroom toilet had an obstruction in the trap of the toilet. After many attempts with the 6' toilet auger it cleared. Nothing was pulled out on the tip of the auger, whatever caused the blockage was flushed away. I tested by flushing large rolled up balls of toilet paper with no problem. -The guest bathroom toilet overflow supply hose slipped out and was not filling the bowl after each flush. I re-attached the overflow hose and tested by flushing rolled up balls of toilet paper.
