REASON FOR TODAY'S CALL:

- Remove garburator under kitchen sink and realign waste water pipe (currently angled the wrong way) - Replace hoses to washing machine with better quality (same as hoses to toilets) - Fix leaking at shower head in master bath

DESCRIPTION OF WORK PERFORMED:

- I removed the garburator, installed a basket strainer in its place, and re-piped the drainage. I also raised the level of the dishwasher drain hose as it was originally set too low. Tested by filling and draining the sink. - I replaced the laundry supply hoses with braided stainless hoses and tested by running the machine through a quick fill & drain cycle. - I tightened 2 loose connections on the shower head in the master bathroom. The shower heads installed in both bathrooms are of a type that can easily come loose when the head is swiveled. If this happens in the future it is just a matter of re-tightening. - I tested all drains and inspected all supply lines. Besides a large clump of hair that I removed from the master bathroom sink drain everything looks to be in good working order.
