 -Unjammed the garburator which had seized up due to rust and tested by filling and draining the sink while running the garburator. -I used the PowerSpin drain snake to clear hair from the master bathroom tub drain. The drain stopper does not stay up on its own so a wedge is used to keep it open while showering. To repair this the tub drain would have to be replaced, Brad said he thinks it is fine for now. - I cleared hair from the top of the master bathroom lavatory drain and tested by filling and draining the sink.
