Issue with shower water temp controls *mentioned while onsite that there is a leak under the kitchen sink *concierge will grant access to floor.

DESCRIPTION OF WORK PERFORMED:

---Nov29: I made a visit to the unit and found that the water temperature was fluctuating and it the water didn't really get very hot. I will contact the Dornbracht rep and inquire about availability of replacement parts. ---Dec6: I was informed by the Dornbracht rep that a replacement cartridge would cost \$800 and is 5-6 weeks away once ordered. He suggest a few things i could try to rectify the issue with the existing cartridge. I made another visit, removed the cartridge and cleaned it out then reinstalled and recalibrated it. Tested and in good working order. I will follow up with Nadine in a few weeks to see how it is going. -While onsite Nadine mentioned that there was a leak under the kitchen sink. I tested by filling and draining both sides of the sink multiple time but could not see any sign of leaking.
