DESCRIPTION OF WORK PERFORMED:  
-The tub spout was not fully diverting water from the spout to the shower head. I replaced the tub spout with a new Delta pull-down type diverter spout. -During the installation of the new spout I noticed a leak emanating from the cartridges within the shower valve. I replaced the mixing & pressure balance cartridges and tested.
