DESCRIPTION OF WORK PERFORMED:
-I used the PowerSpin drain snake to clear hair from the guest bathroom tub and the master bathroom lavatory drains.

TECHNICIAN RECOMMENDATIONS:
Although I was able to retrieve hair from the tub drain it does feel like there is a hard object lodged within the drain as the auger could not push past a certain point. I ran a camera down the drain but it could only reach the ptrap and the object seems to be past that point. I have recommended changing out the tub drain to a lift & turn style drain as it will mitigate the chances of further objects being able to pass through the drain.
