DESCRIPTION OF WORK PERFORMED:
I used the 6' toilet auger to clear the toilet blockage. I tested by flushing large rolled up balls of toilet paper. During testing I found that the fillvalve within the tank is spraying out of the top(which it should not be) and the flapper is starting to warp. No matter how I adjusted it, the toilet itself does not have a very strong flush. I've suggested that instead of spending money on replacing parts within this toilet tank, purchasing a new toilet would make more sense in the long run.
